



Chalk It Up Rangoli Competition 2022

This is for the Chalk It Up Rangoli Competition as part of the *Auckland Diwali Festival 2022* on Saturday 8 October 2022.

The Event Organiser is Tātaki Auckland Unlimited Limited.

By entering this Competition, entrants are deemed to have read, understood, and accepted the following terms and conditions:

a) Pre-selection process

1. To enter, entrants must complete the Competition pre-selection form available at aucklandnz.com/Diwali ("the Website").
2. The entry period for registration commences on Tuesday 20 September and ends on Friday 30 September. Entries received after this time will not be considered for the Competition.
3. Artists for the Competition will then be selected and confirmed by the Event Organiser based on skill, experience, and artistic flair around the design brief. Artist selection by the Event Organiser will be entirely at its sole discretion.

b) The Competition rules

4. The Competition commences at **9am**, Saturday 8 October 2022 and ends at **12pm**, Saturday 8 October 2022 in Bledisloe Lane, located between Aotea Square and Wellesley St West. Qualifying artwork can only be completed within these times.
5. Artists will be allocated a space of 1m x 1m pavement to create their artwork.
6. Artists are only permitted to use **chalk** as their medium.
 - a. Permanent or non-biodegradable materials must not be used as part of the artwork.
 - b. Artists may bring their own tools (such as rulers or compasses) to assist with creating the artwork.
7. The Competition is open to members of the public, aged 13 years and over, who are residents of Auckland. A person can only enter once. Multiple entries will result in an entrant being disqualified.
8. Minors must be accompanied by a parent or legal guardian.

c) Judging entries and Winner selection

9. Artists will be judged on their artwork and a 1-minute verbal presentation to the judges at 11:15am on Saturday 8 October 2022.
10. The Competition Winner will be announced by the judges at **11.45am**, Saturday 8 October 2022. The Competition Winner must be present in the Bledisloe Lane to receive their certificate and for a photo opportunity.

11. If the Competition winner does not acknowledge receipt, cannot be contacted and/or is not available in person to accept the prize in person by **1pm**, Saturday 8 October 2022, the Event Organisers reserve the right to nominate another winner.
12. The Event Organiser's decision is final, and no correspondence will be entered into.

d) Prize

13. The following prize can be won by the Competition Winner:
 - \$200 New World voucher.
14. The Prize is subject to the following terms:
 - a. Must be redeemed within three months of announcement.
 - b. Non-transferable.
15. If the Prize or part of the Prize becomes unavailable (for any reason), the Event Organiser reserves the right to limit entry, cancel or amend the Prizes at its own and sole discretion, including providing the Competition winner with a substitute Prize, either in full or in part.

e) Privacy

16. The information provided on the entry form will be used to contact the Competition winner. In addition, the Competition winner consents to the Event Organiser using their name, suburb, and image for promotional purposes to be displayed on the Event Organiser's website and Facebook page, which will be published after the Competition has ended.
17. The Competition winner also consents to participate and co-operate as required in all promotional activities relating to the Competition.
18. The Entry forms will not be returned. All information provided by the entrants will be collected, used, stored, disclosed and corrected in accordance with the Privacy Act 1993. All entrants have the right to access their information and request for any personal information to be corrected.

f) Exclusions

19. The following persons are not eligible to win any prize:
 - a. Anyone under the age of 13 at the time of entering the competition.
 - b. Anyone not resident of Auckland at the time of the prize draw.
 - c. Anyone who works for the Event Organiser, Auckland Council or any of the Auckland Council-Controlled Organisations, their immediate family members or any agencies or companies associated with the Competition.
20. The Event Organiser reserves the right to exclude any entrant from participating in the Competition at its sole discretion. The Event Organiser also reserves the right to refuse to award a prize to an entrant who is in breach of these Terms and Conditions, gained an unfair advantage in participating in the competition or won a prize by using fraudulent means.
21. The Event Organiser will not be liable for any claims for loss, damage, or injury whatsoever or for any physical or mental injury suffered by any entrant or the Competition winner as a result of or in connection with the Competition or due to the prize won in the Competition.
22. The Event Organiser reserves the right to amend or change these Terms and Conditions at any time at their sole discretion, including extending, postponing, or cancelling the Competition.



23. These terms and conditions shall be governed by and construed in accordance with the laws of New Zealand and shall be subject to the non-exclusive jurisdiction of New Zealand courts.

g) Conclusion

24. Every entrant warrant that all information submitted is true, current, and complete. The Event Organiser reserves the right to disqualify any entrant who does not comply with these terms and conditions.

h) Force Majeure

25. Force Majeure means any intervening cause affecting the holding of the Competition arising from, or attributable to, acts, events, omissions, or accidents beyond the reasonable control of the Competition Organiser, including, without limitation, flood, lightning, storm, fire, explosion, earthquake, other act of God, structural damage, epidemic or pandemic, transport disruption, war, military operations, riot, strike, lockouts or other industrial action, terrorist action or civil commotion.

26. If the Competition cannot go ahead by reason of Force Majeure, the Event Organiser will be under no obligation to hold the Competition.
